**ENTRY**: The competition is open to all fencers with a 2016-2017 FIE licence. Participation in this competition is subject to art. o.54 of the FIE Organisation Rules. Entries being closed at the deadlines mentioned in the article (o.54.2), the competition organiser must establish the list of the exempted fencers and the pools according to art. o.31.2 and o.31.3 of the FIE Rules.

No changes can be made concerning the 16 exempted fencers whose nomination had already been communicated.

The list of attending fencers is the list downloaded latest at 3 pm the day before the competition, according to art. o.31.2 of the Organisation Rules.

**REFERES**: The costs of the referees, who are chosen by the FIE, shall be borne by the Organising Committee. Delegations do not have to bring referees.

**FORMAT**: The matches take place according to the FIE Rules. An information kit for delegations will be published on the website of the organiser <a href="www.fechtertage.de">www.fechtertage.de</a> and of the FIE <a href="www.fie.ch">www.fie.ch</a> latest 2 months before the beginning of the competition.
