1. Nomination of 6 athletes to the Athletes Commission

3. Affiliation of the Angolan Fencing Federation

The Executive Committee pronounced the provisional affiliation of the Angolan Fencing Federation. The number of FIE member federations is now of 152.

4. Medical commission

Dr Azerjwee Usama (IRQ) having resigned from the Commission for personal reasons, Dr. Wilfried Wolfgarten (GER) is joining the Commission.

5. Fair-Play Trophy

The Executive Committee approved the proposal of the Fair-Play Council to establish an annual Fair-Play Trophy.

The Fair-Play Trophy 2017 was awarded to the athlete Jiri Beran (CZE), as proposed by the Fair-Play Council.

6. African coaching academies

The Executive Committee has selected the following cities for the FIE African coaching academies. These academies are appointed for a one-year period:

- Algiers (ALG), for French-speaking students
- Johannesburg (RSA), for English-speaking students

7. Calendar for 2018-2019

The Executive Committee approved the new concept of the calendar for the 2018-2019 season. The Federations concerned will be contacted shortly by the Sport Department.

8. Schedule of events for the World Championships

Further to the various observations received about the disadvantages and constraints of an 8-day programme, the Executive Committee decided to design a 10-day programme.

9. Zonal Championships

Art. 9.4.3 b) of the Administrative Rules has been amended as follows:

b) use of the FIE ranking for the individual and team events, in particular articles o.45, o.46 and o.47 (o.47.1 first sentence and o.47.2) of the Organisation Rules. Teams without FIE ranking will occupy the last places in the table and based on the results of the individual events of the fencers belonging to the teams.
