**Participants:** participation is not Limited;

**Formula:** According the FIE Organization Rules (cf. o. 35 – o. 41);

**Weapon Control:** Will be at the official Hotel and at the Competition Venue, according the FIE Rules;

**Entries:** Open to all fencers with a valid 2018 – 2019 FIE License.

No fencers are allowed to take part in an official event of the FIE unless he or she at least 13 Years old on January 1<sup>st</sup> in the year of the Competition;

Entries of fencers, teams and referees can only be made at the FIE website, [www.fie.org](http://www.fie.org)

Respecting the deadlines specified in the FIE Organization Rules (cf. o. 54);

**Referees:** According the FIE Organization Rules (cf. o. 81. 1. a), the Number of the FIE A or B Grade referees that must accompany teams to the Satellite Competition is:

**1 to 4 fencers:** no obligation to provide a referee;

**5 to 9 fencers:** one Referee;

**10 or more fencers:** two Referees;

**Otherwise, According the FIE Organization Rules (o. 86) 1000. 00 Euro per Referee, to be paid to the Organizers;**

**Entry Fee:** 35.00 Euro-per Fencer. Can be paid at the registration before the start of the Competition;
