### **2) Registration for the Congress, room reservations, visa requests, transfers**

The application will provide you with the information required, change it if necessary, back it up, print and save it on your computer, then send it electronically to the FIE head office and the organiser.

#### **2.1 Registration for the Congress (on [www.fie.org](http://www.fie.org))**

All participants must register for the Congress on the FIE website **before 10 October 2017**.

Each federation is entitled to register the following participants for the Congress: a first delegate, a second delegate, its honorary members and the members of its commissions and councils.

#### **2.2 Hotel (reservations on [www.fie.org](http://www.fie.org))**

Accommodation for Congress participants will be at the Hôtel "Atlantis The Palm Dubai".

The FIE will pay for the hotel room for each national federation's first delegate for the nights of 24 and 25 November 2017.

With regard to the other participants, please find below the rates which have been negotiated (in AED [*Arab Emirates Dirham*]):

- Single room: AED 600 (including breakfast, plus municipal, service and tourist taxes)
- Double room: AED 715 (including breakfast, plus municipal, service and tourist taxes)

The prices mentioned above could be negotiated for the nights of November 24 and 25 only, They are not applicable for other dates.

Rooms for all those taking part in the Congress (including those of the first delegate from each Federation) must be booked on the FIE website, **before 10 October 2017.**

No room reservation can be guaranteed **after 10 October** as the FIE will return the pre-booked rooms to avoid paying for them. After this, the price which has been negotiated and referred to above can no longer be applied.

### **2.2.1 Cancellation policy**

Rooms can be cancelled at no charge **until 10 October 2017. After 11 October 2017,** cancellations will incur a penalty of 100% of the invoice amount.
