**Entry Fee:**

Individual competition: USD 20.

Team competition: USD 40.

The entry fee is to be paid in cash at registration, before the start of the competition.

**Referees:**

All participating countries must be accompanied by an FIE category A or B referee (cf. t.35) according to the number of participants as established in the FIE regulations.

From 1 to 4 participants. No referee required

From 5 to 9 participants. 1 referee

Of 10 or more participants. 2 referees

Each country will cover the expenses of its arbitrators, the organization will cover the lunch of the same during the days of competition.

**Competition System:**

The current system of the FIE will be applied.

**Equipment Control:**

The competitors should use equipment and material approved under the regulations of the International Fencing Federation (FIE). These will be inspected on the following timetable, equipment control will take place at the competition venue

From Tuesday, February 26 to Sunday, March 3 Starting at 7:00

\*Equipment control will only be conducted for fencers who will compete the following day
