Categories: Junior Men's & Women's Foil World Cup, Individual only.

**Participation**: Participation in the competition is open for the athletes having valid FIE license for 2019-2020 season in accordance with the quotas of the FIE.

Entries: Entries must be made via the FIE website at least (7) days prior to competition.

**Entry Fees:** Must be made on-site no less than one hour prior to the beginning of each event. Individual event fees are €25 or \$30 USD.

**Individual Competition Formula**: One qualifying round of pools, a direct elimination table to qualify for a final by direct elimination.

**Equipment:** All equipment must be within the FIE standards.

**Doping Control:** Doping control will be done according to the rules of the FIE.

**Referees:** In accordance with the FIE Rules for the number of FIE A or B Grade referees, countries must provide the required number of referees:

1-4 Fencers: No Referee5-9 Fencers: 1 Referee10-12 Fencers: 2 Referees

Competition Schedule: The schedule is provisional. The organizers have a right to change the program.
