

Participation



Alt 1.

For Individual World Cup competitions, each national federation may enter a maximum of 12 fencers.

The organising country may enter up to 20 fencers plus the number needed to make up the pools.

Alt 2.

Team participation is open to all countries and limited to one team per weapon per country.

Entry

Every competitor is required to be licensed for the 2020-2021 season. No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).



Entry fee



Individual competition: **EUR 60.** Team competition: **EUR 400.**

The entry fee is to be paid in cash at registration in the hotel (accreditation) after the results of the PCR-tests.

Referee Obligation

The referees are designated by the FIE and delegations will not have to provide any referees.



Formula

Individual competitions



One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination.

Team competitions

Integral direct elimination with a direct elimination table which may be incomplete. All places in the table up to 16th place will be fought for. From 17th place onwards teams will be classified, within each round of the table, according to their initial place in the table. The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf. o.86); the remaining ranked teams will be placed in the table by drawing of lots in pairs. The teams that are not classified will occupy the last places in the table and will be separated by drawing of lots (cf. o.42-o.47).



Doping

Doping control will be done according to FIE rules.

ENTRY VISA TO RUSSIA

RUSSIAN VISAS FOR PARTICIPANTS & OFFICIALS

Most nations in the world require a visa to visit Russia

We are pleased to inform you that the Russian Foreign Ministry has approved a special facilitated visa procedure for all categories of participants of the 2021 **International Fencing Tournament**, i.e.

- athletes,
- members of the official delegations,
- international technical officials (referees),
- FIE Family members and official guests,
- as well as media representatives.

All the Russian Consulates throughout the world have been notified of the above procedure. According to it the visas are to be issued on a priority basis, i.e. within three days from the date of application (or on the same day if necessary) at any Russian Consulate regardless of citizenship.

According to this procedure, you are to make a request for the visa support on the official paper of your National Federation signed by the President or the General Secretary.

At the same time you have to complete the below visa template with the personal passport information of the members of your delegations

In compliance with the provided official request and personal data a scanned formal invitation letter will be issued & e-mailed back to you. It is to be taken to the nearest Russian Consulate along with your corresponding personal documents such as the passport, the necessary number of pictures, completed application form, etc. in person or by a representative. Some consulates of the Russian Federation accept postal applications. Though there is a number of consulates, where personal attendance is required for fingerprints. All details are to be checked on the consular website in advance.

As the above visa procedure is exceptional, please make sure you mention that you are applying for the Russian visa to attend the 2021 International Fencing Tournament

All the requests for the visa support must be sent to epeekazan2021@gmail.com no later than 5th of March

Each delegation has to fill the form and send it to epeekazan2021@gmail.com before the 5th of March, in order to have it presented to the boarder authorities in time

COVID-19 SPECIFIC RULES

It is mandatory to all participants to follow the rules:

- Participants shall arrive on the 16th of March (the 17th of March as the latest, if there are difficulties with corresponding flights, etc)
- Covid-19 tests must be done not earlier than 72 hours before the arrival time to Russian Federation, in order to be presented printed to the boarder control authorities
- All participants will be subject to a PCR test on arrival to Kazan, expenses for this ONE test to be covered by the FIE
- Results will be declared within 12 hours by the email
- All participants must stay isolated in their Hotel room until the result declaration
- Late arrivals of participants will not allow PCR test results to be obtained on time for training and competition. In such cases, participants will not be authorized to take part in the competition as per FIE rules. The latest time of possible arrival – 23:59, 18.03.2021
- Accreditation cards will only be given to participants that provided a negative test result, they can be picked up by the heads of delegations at particular time (will be communicated upon arrival) in each official hotel, the entry fee is to be paid at the same time
- Visas, Transfer and Hotel Booking must be done ONLY through the mentioned in the invitation letter contacts
- Tickets and passport copies must be provided in advance for entering the country, as the list of the names has to be obtained by the authorities (on the border)
- Participants can go for training if sample tested Negative for Covid-19
- If it is needed to be tested before the departure to the home country, you need to inform the organizers about it in advance, expenses for it to be covered by each National Federation (a price for one test - € 20)
- Participants are not allowed to leave the hotels for any activities besides the official trainings and competitions
- Transportation and logistics must be in line with protocol guidelines, a service is planned to and from the official hotels to the competition venue.

- No spectators will be allowed to the competition venue
- Trainings will be also according to the schedule, the teams will receive information one week before the event.
