

#### **ENTRY FEE**

The entry fees are fixed at 30 Euro per fencer for the individual event to be paid to the organizers at the moment of registration (FIE Regulations).

#### **ENROLMENT**

The entry of the names of the fencers and all possible replacements must be made via the FIE website 7 days before the competition at the latest (midnight Lausanne time).

#### REFEREES:

In accordance to the FIE Rules the number of FIE A or B Grade referees that must accompany teams to competitions is:

1–4 fencers No obligation to provide a referee

5–9 fencers One referee 10 or more fencers Two referees

For sattelite turnament competitions, the name (s) of the referee(s) (who must have an FIE category in the weapon of the competition for which they are entered) must be notified via the FIE website 7 days before the competition (midnight, Lausanne time).

Should a national federation not provide the required number of referees, a fine (cf o.86, table of financial penalties and fines) will be inflicted on it.

#### **ANTI-DOPING CONTROL**

Doping Control will be carried out in accordance with the FIE rules.

#### **TRANSPORT**

The Organising Committee will provide the transportation from Sofia airport to Plovdiv and back at the price of 45 euro/person

#### **ENTRY VISA**

In order to obtain a visa, participants are requested to send to <u>bulfencing@gmail.com</u> the visa form. The Organising Committee will take care of the necessary formalities before 1 September 2021.

#### **Entering this country with the EU Digital COVID certificate**

Provisional information subject to further revision and confirmation from National Authorities

In order to be valid to enter Bulgaria, the EUDCC should contain one of the following:

• **Proof of vaccination**, valid **from 14 days after the second dose**, or from 14 days after the first dose if the vaccine is administered in a single dose (Janssen/Johnson&Johnson);

- **Proof of recovery from COVID-19**, valid **180 days** (at least 11 days after the positive result to a COVID-19 test).
- Negative result to a COVID-19 test.
