## 2. Important information about sanitary measures - COVID 19

### Important NOTE:

**Before your travel:** You must consult with your airline and/or Mexican Embassy in your residency country about the requirements to travel to Mexico, it can be different according with the selected airline, your departure country, or the countries in transit.

**At Mexico there's no mandatory quarantine upon arrival or departure from Mexico, according with the Mexican Authorities.**

**The PCR test is not obligatory for arrival or departure to Mexico**

REQUIREMENTS FOR COVID 19 RISK MITIGATION

- a) We are all aware of the impact of Covid 19 on the sports events, so, the satellite World Cup WILL BE HELD ON A "Bubble mode". "Bubble is a generic term for isolated competition venue"
- b) All the delegation members (including staff members and companions) must follow the Covid 19 preventive plan, and must follow all dispositions including among others, the following:
  - I. Upon arrival to the official hotel, all participants must provide a completed and signed Appendix B and C and all the sanitary rules of the mitigation risk plan according to the FIE
  - II. Get tested for COVID antigens at the official hotel assuming it's cost
  - III. Not allow people that are not properly accredited at the rooms or exceeding the authorized room occupancy.
  - IV. All participants should respect the sanitary rules instituted by the public local health department.
  - V. On the same basis, all participants are subject to the lodging rules of mandatory accommodation, arriving on October 1st, and remaining on observation at least the previous day. All participants cannot leave the hotel, or the reentry will be denied.
- c) Also, they agree:
  - I. Arrive to the hotel on October 1st, 2021 to get tested for Covid 19
  - II. The application by the medical crew or designated to apply the rapid PCR or rapid antigens test by vein punction or nasopharyngeal swab exclusively administrated by the organization.



- III. Follow strictly the protocol rules including the mandatory use of face mask and the sanitary mask is recommended.
- IV. Frequent corporal temperature measurement. Use of sanitizer mats and surfaces, application of sanitizing gels and liquids. Objects and personal belongings and competition material thru various methods to avoid contagion.
- V. Same way, participants accept the negatory instruction of participation in case of a positive result on the Covid 19 test applied by the organization or in case of any violation of the sanitary protocol; the fault would be determined by the organization and/or the medical crew that Will participate on the event
- d) Participants cannot leave the “sanitary bubble” between the arrival and departure of the official hotel. Due to epidemic dispositions the probability of infection with Covid 19 is very low inside the bubble.
- e) Public and spectators Will be restricted to the limit occupancy on the venue.
- f) By confirming your participation you’re exempting of the contagion risk to SARS CO V2 COVID-19, to the organization, also you acknowledge the regulations and security measures for this sport and voluntarily assume the risks on being exposed to Covid 19
- g) Any participant with a positive covid 19 result Will be denied the access to the competition venue, to the hotel and to all competition related areas. They will be invited to leave the place. All expenses that they incur due to cancelation for covid 19 contagion will be responsibility of the affected and in no way of the organizing comity or the Mexican Fencing Federation.
