1. ENTRY

This tournament is open to all men junior sabre fencers with the FIE license valid for the 2020-2021 season. The inscription of athlete and referees must be done via the FIE website, according to the FIE rules and deadlines.

Entry Fee

The entry fee of 35 \$ must be paid to the organizers during the registration. Entry fee for the team event is 150 \$. The payment can be via bank transfer in advance or be accepted in cash at the venue during accreditation the weapon control.

According to the FIE rules the number of FIE A or B Grade referees that must accompany teams to competitions is:

1-4 fencers no obligation to provide a referee

5-9 fencers one referee 10 or more fencers two referees One junior team one referee

5. DOPING

Doping control will be done according to FIE Rules.

6. VISA

Most countries are required to have a visa to visit Uzbekistan.

The organizer is happy to help any country with obtaining visa for athletes and officials. Please visit www.e-visa.gov.uz fill out the online application and make a payment fee in order to issue an electronic visa, approximate time to issue a visa is 5-6 business days.

For country, who need a visa support letter should go through the following steps:

- 2. Send us the request information according personal information (the form will send after request)of the participants
- 3. Send us the copy of passport

Important information:

10.IMPORTANT INFORMATION REGARDING COVID-19 SPECIFIC RULES:

The fundamental principle throughout all FIE events during Covid 19 is to protect and be protected by wearing masks, sanitizing, and respecting the FIE Outline of risk-mitigation requirements.

FIE Outline of risk-mitigation requirements apply to all participants. Each participant (athlete, coach, physiotherapist, doctor, official etc,) must have read and understood last version of the FIE COVID 19 Protocol which can be find here https://static.fie.org/uploads/24/124713-FIE_outline_risk-mitig_Covid-19%20ang.pdf

- The Borders open for all countries.
- Upon arrival the each participant must present negative (PCR) test for Covid-19 at the airport.
- After arriving to the Hotel, will be organize the rapid PCR test at the official Hotels, that will covered by FIE. After receiving the result of the rapid PCR test, participant could go to the accreditation Center and weapon control (according official rules of FIE).

- Accreditation cards will only be given to participants who provided a negative Rapid PCR test.
- Official transfer buses will take participants to and from the Official Hotels. No other means of transport is allowed.
- Any participant tested Positive to Covid-19 will be quarantined for 10 days in the official declared hotel or hospital.

PCR test before departure that will required of participants to return home, the organizers will provide it. The cost of the PCR test for departure is 20\$ per person.

- No spectators will be allowed to the competition venue

COVID Protocol:

- obligatory wearing of the masks every time except during the bout and having a meal
- obligatory distance : 2 m. between each
- other hand shaking after the end of the bout is forbidden, salute must be applied
- hand shaking after the end of a team event is forbidden, only salute by the team captain shall apply.
- screaming during a bout is forbidden
- distance of 2 m between the coach and the fencer must be respected at any time
- any person not participating in the event (eliminated fencer after a pool or a table, his/her coach, medical staff, etc.) must leave the venue and are not allowed to stay in the venue as a spectator.
