## 3. Entries

Entries must be made by the National Federations on the FIE website, in accordance with **Article o.54 of the FIE Rules**.

## 4. Registration fees

**A/ Individual events:** An entry fee of **15 EURO** per fencer will be paid to the organizers at the site before the event.

**B/ Team events:** An entry fee of **50 EURO** per Team must be paid at the site before the event.







## 5. Weapons Control for athletes

Weapons Control will take place:

- At the designated area next in the Fencing Hall on February 22<sup>nd</sup> from 3pm to 8pm.
- At the designated area next in the Fencing Hall from 8pm to 10pm and from 12pm to 1pm during the days of the competition.

## 6. Information points

Two information points will be displayed:

- 1. Close to the Technical Director
- 2. At the entrance to the fencing hall.

Only fencers involved, referees and the personnel for the pistes are allowed to enter the zoned off areas using barriers. Venue Securities will control access to the zoned off areas.

Fencers in the zoned off areas are required to keep their belongings in their closed fencing bags at the end of the piste and leave the piste immediately at the end of the match.

All fencers and referees are required to be present on the piste for pool rounds, 10 minutes before the start of matches.

Attention: In some instances, the matches might start 5 minutes before the scheduled time.







## 7. Competition Details

## Competition Venue

Festival Hotel Hall, Festac, Lagos Nigeria



We will post:

At 8:00 pm the day before competitions in the venue and in the official hotels

- the lists of fencers / registrants
- qualifying pools with the schedule for each pool and the piste

#### Confirmation of results

- It is the responsibility of the fencers to check the pool results and the direct elimination sheets to verify that the results are correctly recorded. The tables installed in the different places in the room will allow a quick check of the updated results of the rounds of pools and direct elimination matches.
- To avoid any kind of mistake, the D.T. will publish the pools results and the list of qualifiers and those eliminated after the round of pools as soon as it is over. Fencers or National Federation representatives must submit any objections within 10 minutes.
- The direct elimination tables with time and piste will be displayed after the rounds of pools.
- No calls will be made by microphone for pools.







#### Presentation of finalists

- The 6 finalist fencers will be presented on the piste to the public, before the start of the finals by announcing their track-records.
- They will have to present themselves in fencing uniform, weapon in hand.
- They will greet the public guard on the chin.
- The referees of the final will be presented as well.
- The Finalist Award Ceremony will be held 10 minutes after the end of the final match of the day.
- There will be no special awards on the podium.
- According to the specifications of the FIE "each delegation is responsible for the anthem and the flag of his country".

# COVID- 19 SAFETY GUIDELINES FOR THE 2022 JUNIOR/ CADET AFRICA FENCING CHAMPIONSHIPS

IMPORTANT INFORMATION FOR ALL ATTENDEES TO INCLUDE PLAYERS, COACHES AND ALL MATCH OFFICIALS

#### PRIOR TO ARRIVAL

- All participants must undergo a PCR [polymerase chain reaction] swab test a maximum of 48hours (2) days prior to their arrival, with evidence of negative test result presented via email to the LOC on or before departure from home country.
- Participants are to visit <a href="https://nitp.ncdc.gov.ng">https://nitp.ncdc.gov.ng</a> portal to fill out the forms and register before departure.
- For participants who tested positive in the past, they may be required to provide evidence of negative test before registration or allowed to complete.
- Participants are enjoined to receive the approved vaccine in their home countries and bring evidence of vaccination except for cadet participants.
- Participants are required to take a departure COVID- 19 PCR test as required by the rules of the NCDDC of the host country.
- It is the responsibility of all participants to comply with regulations and tests to enter the country, at their expense.
- Participants needing a Covid-19 test to go back to their home country must inform the LOC and make an appointment according to their departure time. These tests are at the expense of participants and results of tests will be printed and provided to the participants in the hotel.

#### **UPON ARRIVAL**

- All participants will undergo a compulsory COVID- 19 test before participation in any of the games (this also applies to vaccinated participants). No isolation is required unless the test is positive. This also applies to all host country participants.
- Any Participant who test positive to Covid-19 after will not be authorized to take part in training or competition and must comply with all quarantine requirements which includes implementation the local laws of contact tracing and isolation protocols as the country rules are applies.
- Participants will receive official notification if COVID- 19 test result is negative via the communication channels.





- During the duration of the competition another COVID- 19 test will done at every 4 days after arrival day, unless that 4th day is the day of departure of the participant.
- Refusal to take the test results in dismissal of the attendee from participation in any of the event or entry into neither the match venues nor the residential areas.

Participants at who experience any COVID-19 symptoms must contact the designated medical liaison immediately. Hiding, concealing and not reporting COVID-19 symptoms will be considered an intentional violation of the Official FIE Outline, and subject all those involved to immediate sanctions and penalties by the FIE, and also to sanctions as determined by the applicable laws of the host country.

#### **DURING THE EVENT**

#### For Fencers:

- Sharing equipment with another participant is not allowed.
- Hand disinfection before and facemasks are obligatory at all times, except when training, fencing and eating
- Sanitary Distance of 1.5 meter should be maintained at all times.
- Fencers should bring their own bottle of water and must not share it with it anyone.
- Fencers should bring their own pen to fill in and sign documents.
- Fencers' handshake at the end of bouts is now replaced with a salute.
- Exchanging gifts is suspended until further notice.
- Screaming after a hit is scored is discouraged.
- Rushing to the victorious fencer on the piste or after the fencer leaves the piste is suspended until further notice.
- Congratulatory hugging, kissing or handshakes are suspended until further notice.
- Fencers can only sit in areas designated while preparing for the competition, but they must keep the required distance.
- Breaching of the Covid-19 protocol or refusing to obey the Covid-19 protocol will be sanctioned by the withdrawal of the accreditation and exclusion from the event.
- Fencers are exempted from wearing a face mask during the rest periods. During rest periods, all people in the fencing piste area will have to maintain a distance of 1.5 meter from the fencer(s).
- Fencers are responsible for disinfecting their fencing masks, uniforms, weapons and fencing equipment. Daily disinfection of fencing mask is highly recommended and sharing is NOT allowed.
- Fencing gloves are must be often disinfected, at least once a day. Fencers must wear PERSONAL glove and glove sharing is NOT allowed.





#### For Coaches:

- Coaches are allowed to stay at 1 meter from the fencer but must wear a facemask at all
- Facemasks are obligatory at any time, except eating.
- Rushing to the victorious fencer on the piste or after the fencer leaves the piste is suspended.
- Congratulatory hugging, kissing or handshakes are suspended.
- Breaching of the Covid-19 protocol or refusing to obey the Covid-19 protocol will be sanctioned by the withdrawal of the accreditation and exclusion from the event.

#### At the Hotel:

- Social distance protocols must be adhered to at all times and face masks should be worn at all times in the hotels (except while eating).
- While in transit, participants are advised to always use their face masks and avoid boarding buses/cars at full capacity.
- Anyone who is feeling sick is advised to notify the LOC officials who will then contact the medical unit to examine and a COVID- 19 test may be conducted.
- Participants are advised to avoid leaving the hotels beside for match or training sessions.

#### At the Venue and Warm-up Areas:

- Availability of hand sanitizers shall be guaranteed at the entrance and exit to the venue, the call area and in the field of play.
- Face masks should be used by all participants at all times except by players during practice and competition.
- LOC shall ensure proper floor markings to avoid contact and encourage social distancing in the field of play, and at the entrance/exit.
- Participants are encouraged to avoid inter mingling with other people as much as possible.
- During practice and warm-up sessions, fencers are advised to follow hygiene rules; use of the hand sanitizers provided, avoid sharing of towels bring enough face towels (maybe one or two per day) to wipe off sweat from your face. Do not use your hands or wipe the sweat with the sleeve of your uniforms. Avoid putting your face towels on chairs next you
- If participants are not practicing or competing it is advised that they stay back in the hotel room or stay in player designated areas at the venue as they avoid inter mingling.

- During practice and warm-up, fencers should avoid having more than one (1) accompanying person.
- Members of the same team must also maintain Sanitary Distance while at the venue.
- Daily disinfecting of all working surfaces (Tables, chairs, storage areas, test equipment, etc.) at the Entrance areas, Referees Room, DT area, Weapon Control Area, Call Room, Page | 4 Each pist will be done.

#### **Before, During and After Bout:**

- Referees will use hand-disinfectant before and after each bout.
- Referees will use facemask when performing a weapon test and during bouts.
- Referees will inform all the fencers about relevant limitations/restrictions: Shaking which includes hands, fist bump, hugging, shouting after touch and so forth
- Exchange of masks, gloves, cables not allowed.
- The practice of rushing the victorious fencer on the piste or after the fencer leaves piste is suspended until further notice.
- Social distance guidelines must be adhered to at all times in the call area and in the field of play during a bout.
- In case of injury only doctor as well as medical staff of the competition and their team members can approach the injured fencer and they must wear facemasks.
- During award and medal presentation fencers will pick up their awards and avoid hugging, shaking hands and fist bumping.

#### **OPTION 2**

We handle the visa application for you.

You Send us a list of delegates (participants and guardians) coming for the competition. Kindly refer to the visa application form found in the information package document.

In addition, the following documents stated below must be attached.

- Bio Data Page of the passport
- Booked flight details

Visa and biometric fees will be sent to us via the designated account details provided in the information package.

The process takes 4-5 business days.
