#### **COVID Protocol**

Following the rules of the German government, the government of the state Baden Württemberg, the county Main-Tauber, the city of Tauberbischofsheim and applying the "FIE outline risk mitigation COVOD-19" guidelines of the FIE the following protocol is in place:

- 1) Entering Germany: Please refer to the actual regulations of the German government which can be found here: <a href="https://www.bundesgesundheitsministerium.de/en/service/gesetze-und-verordnungen/guv-19-lp/coronavirus-einreiseverordnung.html">https://www.bundesgesundheitsministerium.de/en/service/gesetze-und-verordnungen/guv-19-lp/coronavirus-einreiseverordnung.html</a>
- 2) Registration to the competition: Every participant must undergo a RAT (rapid antigen test) after arrival and again four days after arrival. This operation is subsidized by the FIE. The tests are free to athletes, coaches, officials and referees. People with a negative test result will receive a bracelet as Identification after presentation of the negative test result. Only people with valid bracelet will be able to enter training and competition. Authorities will be able to control at any moment.
- 3) Departure tests: If you need a departure test (RAT 29 €, PCR 79 €) you will need to make a reservation by sending an e-mail with the required number of tests to <a href="worldcup@fechtentbb.de">worldcup@fechtentbb.de</a> by 23.04.2022 at latest.
- 4) Positive testing: In case of a positive result by RAT a confirmation test by PCR will follow. The tested person with positive RAT result must immediately go to his room and stay there under quarantine conditions until the PCR result is available.
  - The OC is required to transmit the full dataset of every person tested positive by PCR to the authorities. Legislation requires that persons tested positive have to be isolated immediately. The length of the isolation is regulated by the actual rules of the German government and will last seven days at minimum (status March 2022).
- 5) Form B and Form C of the FIE guideline (https://fie.org/fie/documents/other-documents) have to be completed and signed after the arrival in Germany. These documents have to be handed over to the organizers during accreditation.
- 6) Sanitary Measures according to the actual "FIE outline risk mitigation COVID-19" guideline.

# **Participation**

Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.

Team participation is open to all countries and limited to one team per weapon per country.

# **Entry**

Every competitor is required to be licensed for the 2021-2022 season.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Entries of fencers, teams and referees can only be made at the FIE website, <u>www.fie.org</u>, respecting the deadlines specified in the FIE Rules (cf. o.54).

## **Entry fee**

Individual competition: EUR 60. Team competition: EUR 400.

The entry fee is paid for each national delegation by bank transfer to:

The entry fee can also be paid at registration before the start of the competition.

### **Referee Obligation**

The referees are designated by the FIE and delegations will not have to provide any referees.

### **Formula**

Individual competition – One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination.

Team competition – Integral direct elimination with a direct elimination table which may be incomplete. All places in the table up to 16th place will be fought for. From 17th place onwards teams will be classified, within each round of the table, according to their initial place in the table. The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf. o.86); the remaining ranked teams will be placed in the table by drawing of lots in pairs. The teams that are not classified will occupy the last places in the table, and will be separated by drawing of lots (cf. o.42-o.47).

# **Doping**

Doping control will be done according to FIE rules.
