## **Participation**

Each national federation may enter a maximum of 12 fencers. The organizing country may enter up to 20 fencers plus the number needed to make up the pools.

#### **Entry**

Open to all fencers with valid 2021-2022 FIE License.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on1 January in the year of the competition.

Entries of fencers, teams and referees can only be made at the FIE website, <u>www.fie.org</u>, respecting the deadlines specified in the FIE Rules (cf. o.61).

## **Entry fee**

Individual competition: EUR 100.

The entry fee can be paid in cash at registration before the start of the competition.

## **Referee Obligation**

The referees are designated by the FIE and delegations will not have to provide any referees.

#### **Formula**

One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64fencers to qualify for a final by direct elimination

#### **Doping**

Doping control will be done according to FIE rules.

Participants needing a Covid-19 test to go back to their home country must send an email the LOC and make an appointment according to their departure date/time. These tests are at the expense of participants.

PLEASE NOTE! If the event is cancelled due to the implementation of Governmental policies and/or in case of restrictions or bans to travelling to Italy, or if a ban is introduced on holding public events, this shall be considered as a "force majeure circumstance" and no penalties are applied. Likewise, if a participant's Country should place a ban on travelling to Italy, this shall be considered as a "force majeure circumstance", on condition that participants can prove such travel restrictions with an official notification to the COL, who will in turn pass the information on to the hotel.
