

## **GENERAL RULES OF THE TOURNAMENT**

The competitions are organized in principle according to FIE Rules. Name and nationality on the back of fencers are obligatory

- National colors obligatory
- Video refereeing will be available
- Wireless system will not be used must

#### ACCREDITATION AND CONFIRMATION OF PRESENCE

Final Confirmation of participation at individual and team competitions must be done within delivery of accreditation cards (AC), this proceeding replaces any kind of confirmation of presence at the DT.

The AC will be distributed only to head of delegations.

The accreditations of fencers must be done before 17h00 the day before the competition.

# Rules and principles of getting accreditations

The accreditation cards (AC) are issued for delegations regarding FIE rules under conditions as follows:

- Any AC for athlete is personal with photo
- Personal ACs with photo are issued for officials of delegations with concerned NOC indication (National Olympic Code). The number of cards is proportional by 100% to the number of participants in individual competitions.
- Besides quota for officials, President and General Secretary of concerned delegation present at Championships are entitled to obtain their personal AC.

# **Championships COVID protocol**

# **Covid-19 entry rules**

In order to enter Türkiye, the participants have to present proof of one of the following options:

- a) Certificate of negative test for COVID-19; or
- b) Certificate of recovery from COVID-19; or
- c) Certificates of vaccination against COVID-19 with any WHO-recognized vaccines; or
- d) Certificates of vaccination against COVID-19 by any vaccines recognized by Turkey.

Based on an exemption issued by the Ministry of Health of the Republic of Türkiye, the following participants are allowed to enter Türkiye and are exempted from quarantine if they can provide a PCR test negative result taken within maximum 72 hours before arrival to Turkey:

- Participants flying directly from Red Zone Countries or South Africa, Botswana, Mozambique, Namibia, Zimbabwe, Brazil, Nepal, Sri Lanka, Bangladesh, India and Pakistan
- Participants who have been in these countries within the last 14 days and planning to enter
- Türkiye from another country;
- Participants who are not vaccinated against Covid-19 or whose vaccine is not recognized by
- WHO and/or Türkiye.

## **FIE Outline for risk-mitigation**

- appendix C) COVID-19 SCREENING QUESTIONNAIRE FOR FIE EVENT
- 3) All participants will be tested upon arrival with a Rapid Antigen Test (RAT). The test is free for athletes, coaches, officials and referees.
  - No isolation is required unless the rapid antigen test is positive.

- Results of tests will be communicated to each participant individually.
- Participants who receive a negative result of the Rapid Antigen Test will be provided with a bracelet allowing them to enter the venue.
- All organizers, staff or workers, has to do test and ensure all teams, employees, workers during the competition are covid-19 free.
- Participants who got covid-19 vaccine are not excluded from test.

#### Test and bracelets

All participants will be tested at least once with the Rapid antigen test (RAT) after their arrival in the country. The tests (RAT) will be held in the designated area in the venue. Results will be given in 15 to 20 minutes. The tests will be done in smaller groups.

Upon negative result, they will receive a colour-coded wristband with a validity for the whole championship.

Additional Covid-19 tests are no longer required during the competition.

Then you can move on to other processes (accreditation and weapon control). Please note that all other procedures (registration, accreditation and weapon check) will not be possible before the test!

In case of positive result, please read the procedure below.

#### Positive COVID-19 test result

In the case of a participant gets a positive result for COVID-19 after an antigen test, he/she will have to take a PCR test. If a PCR test is positive, he/she will:

- Be immediately placed into isolation in a single room (at their own cost)
- He/she will be taken immediately to a doctor for examination
- Depending on the doctor's examination conclusion, actions to be followed will be defined

If a participant has a positive PCR test, he/she will have to be placed in an isolation room at the expense of the participant / travel insurance if applicable, or at the designated hospital if needed. He/she will not be allowed to return to their country of origin until their isolation period has been completed.

The Organizations COVID-19 Manager will follow up on the patient's situation directly with the relevant Team Manager.

All individuals placed in isolation should be isolated for 7 days and not have any contact with any other individuals during that period. If the results of the PCR test to

be performed at the end of the 5th day are negative, the quarantine will be terminated.

In case of a positive result on PCR test after 5&7 days, the participant will continue his/her isolation for another 7 days. This process will continue until negative result. As a result of any isolation periods, the Organizations COVID-19 Manager will liaise with the hotel and support the National Federation with requirements.

The costs of quarantine, isolation, and medical care are at the expense of delegations/participants.

It is strongly recommended to have an appropriate health insurance to cover routine medical healthcare, including COVID-19 care, hospitalization and, in case of isolation, that such insurance cover has no exclusions or limitations regarding the length of stay, as all costs related to a positive COVID-19 will have to be borne by the participant.

# **Developing symptoms during competition**

If any participant develops symptoms during competition, he/she shall immediately:

- Inform the Organizations COVID-19 Manager
- Isolate himself at the official hotel in a separate room
- Have a COVID-19 test at the hotel or competition venue (cost to be supported by the participant)

# **COVID Testing fees and results communication**

On arrival RAT costs will be supported by the organizers. Departure and other (symptoms/close contact/PCR test after a positive antigenic test) tests will be supported by the participant. PCR tests are 50€, RAT is 20€.

RAT results will be communicated directly to the participants 15-20 minutes after sampling. PCR test results will be distributed by email and text message to the tested participant within a maximum of 8h.

## **Testing area working hours**

The COVID-19 testing area located in the venue will be open every day from 09:00 to 17:00h.

# Face masks

All participants are required to wear face masks (the types of face masks are detailed in the FIE Outline of risk-mitigation or on WHO website: <a href="https://www.who.int/news-room/q-a-detail/coronavirus-disease-covid-19-masks">https://www.who.int/news-room/q-a-detail/coronavirus-disease-covid-19-masks</a>), except when fencing, training and eating. All Spectators are required to wear face masks at all times.
