### Participation:

Participation is not limited.

### Entry:

Open to all fencers with valid **2022-2023 FIE License**. No fencer may obtain an FIE licence, enabling him or her to enter for an official FIE competition, until he or she has reached their 13<sup>th</sup> birthday.

**Entries of fencers and referees can only be made at the FIE website, [www.fie.org](http://www.fie.org), respecting the deadlines specified in the FIE Rules.**

### Entry fee:

Individual competition: **300 HRK (40€)**

The entry fee is paid at registration desk before the start of the competition.

### Referee Obligation:

Each country is required to send FIE qualified referees in accordance with FIE rule o.25:

1–4 fencers	- No obligation to provide a referee
5–9 fencers	- One referee (FIE A or FIE B)
10 or more fencers	- Two referees (FIE A or FIE B).

**\* The name(s) of the referee(s)** (who must have an FIE category in the weapon of the competition for which they are entered) **must be notified via the FIE website 7 days before the competition** (midnight, Lausanne time).

*\* Should a national federation not provide the required number of referees, a fine according to FIE Organisation Rules (cf o.31, table of financial penalties and fines) will be inflicted on it.*

*\* Non respect of quota is sanctioned by 1000 € for every missing referee per competition and shall be paid by the fencers National Federation to the Organizer at the same time as the information is sent to the Organizer (according to FIE Rule o.31.)*

### Formula:

According to FIE regulations, formula for junior competitions. One round of pools, from which 20-30% of fencers will be eliminated, followed by Direct Elimination without repechage.

### Prizes:

**Cups for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places** assured by Organisers both for male and female winners, sponsor gifts.

### Doping:

Doping test will be conducted according to the FIE rules.

### Accommodation and Transport:

All delegations must arrange for their own accommodation and transport.

### Visa Support:

We suggest all fencers requiring Visa to ask for a tourist visa, considering that our Ministry of foreign affairs started to charge a process for sport visa.

In case you can't apply for a tourist visa, we will help you with the process and will charge you only for the cost that is required by our Ministry of foreign affairs.

#### COVID-19 RULES:

It was decided that the following measures will be implemented during FIE competitions until further notice: - **Facemask**, except when fencing, training and eating;

**Participants (fencers, referees, coaches, accompanying persons)** will **need to present** to the organisers the **negative result of one Covid-19 test** (PCR or RAT – Rapid Antigen Test), **performed within maximum 72 hours before the arrival in the country**.

Other sanitary measures at the competition may be implemented by the host federation at their option or as required by the national authorities.

**Negative results of one Covid-19 test must be PRESENTED PERSONALLY AT COMPETITION VENUE before** Payment-Registration/Weapon Control and will be exchanged for a bracelet/accreditation needed for entering at the competition venue.

#### Final notice:

The athletes are competing on their own risk. The Organizers are obligated to assure the first aid health care but without any further responsibility. The Organizers have no responsibility for lost or stolen properties.

The participants agree on publication of images and films taken from the tournament.

#### General information:

Currency used in Croatia is Croatian kuna – HRK. Current rate is approximately 1 EUR = 7,5 HRK.

Official language: Croatian (many people speak English)

Area code: +385; EU rule "Roaming like home" applies to Croatia.

In Croatia, tap water is drinkable.
