## Participation

Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.

## Entry

Open to all fencers with valid 2022-2023 FIE License.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Entries of fencers, teams and referees can only be made at the FIE website, [www.fie.org](http://www.fie.org), respecting the deadlines specified in the FIE Rules (cf. o.54).

## ENTRY FEE:

An entry fee of € 100 per fencer will be given to the organiser until 17:00 on 26<sup>th</sup> April at the desk in the venue.

## Referee Obligation

The referees are designated by the FIE and delegations will not have to provide any referees.

## Formula

One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination. For your information, Please check FIE Website and KFF website (<http://fencing.sports.or.kr>)



## Doping

Doping control will be done according to FIE rules.

## **COVID-19 Outline for the season 2022-2023(FIE)**

Covid-19 plan for the 2022-2023 season The sanitary measures at FIE competitions have been adapted as follows, until further notice:

- Wearing a sanitary mask is no longer compulsory, but remains recommended;
- Participants will have to present to the organisers the negative result of a Covid-19 test (PCR or Rapid Antigen Test), carried out within a maximum of 72 hours before arrival in the country.

Other sanitary measures at the competition may be implemented by the host federation at their option or as required by the national authorities. However, in case the covid-19 situation would worsen, the sanitary measures will be revised accordingly and federations will be informed immediately.



## COVID-19 outline of overseas arrivals

The current entry rules for Korea are as follows. As soon as the regulations are relaxed or changed, KFF will send updated covid-19 regulations to FIE and all World fencing families.

### Arrivals from ordinary country

(Countries other than China, Hong Kong, and Macao)

Categories	Voluntary PCR screening within 3 days of arrival	Isolation of confirmed cases
Short-term stay foreigners	No	Home, Hospital, Home isolation facility to be entered

### Arrivals from China, Hong Kong and Macao

Categories	Negative Confirmation Certificate prior to arrival	PCR screening within 3 day of arrival <b>(Recommendations)</b>	Isolation of confirmed cases
Short-term stay foreigners	Submit	*Airport screening center (cost to be borne by the traveler) <b>(Recommendations)</b>	Home, Hospital, Home isolation facility to be entered

#### ◆ Obligatory use of Q-CODE by arrivals from China ('23.1.2. ~ 3.10)

- Input quarantine information in Q-CODE and complete issuance of QR Code prior to boarding plane

#### ◆ Obligatory screening prior to arrival for those coming from China ('23.1.5. ~ 3.10)

- Must bring PCR Negative Confirmation Certificate for screening conducted within 48 hours or RAT Negative Confirmation Certificate for specialists for screening conducted within 24 hours with 00:00 of the date of departure as the reference (those without such certificate won't be allowed to board the plane)

Negative Confirmation Certificate prior to arrival and obligatory use of Q-code arrivals from China, Hong Kong and Macao is only **until 10 March 2023**.

**\*\* Athletes departing from China, Hong Kong, and Macau must check the regulations at the local Korean embassy.**





## Visa

All the incomers from outside of Korea must apply for **K-ETA or Visa** in advance. You can easily apply K-ETA via website. It is valid for two years since issuance.

### **1-2. Countries not applicable to issuing K-ETA, must need Visa from the Embassy**

Please check the Korean Embassy in your country about whether you need the visa or not and please contact to KFF and request for **visa invitation letter**.
