## CHAPTER I - MISSION

## 1.1: Mission

Federation $X$ is an independent organisation recognised by NOC of country $X$ as sole body governing sport of fencing in country X .
Its statutes and regulations comply with the Olympic Charter, the Statutes, Rules and regulations of the FIE and the anti-doping rules of the FIE and WADA; if any conflict arises between its statutes and regulations and the Statutes and rules of the FIE, those of the FIE take precedence.

### 1.2.Aims.

Examples; administer sport nationally, manage finances, promote development and spread of sport overall and provide support and advice, promote among children and young people, involvement in education, promote affiliation of clubs, promote safety of and respect for individual, fair play and sportsmanship, promote respect for environment, apply FIE rules for competitions, organise competitions in country, preparation of national teams, participate in international competitions, ensure independent democratic election processes within electoral cycle, etc etc.
Compulsory aims: to ensure that principle of non-discrimination on grounds of gender, race, ethnicity, religion, political opinion, family status or other is respected: To promote and develop fight against doping: To adhere to the FIE's code of Ethics and its Safeguarding Policy.

## CHAPTER II - MEMBERSHIP

### 2.1 Categories of members

The Federation can have three (3) categories of members:
> Club or similar member

- clubs or legal entities that meets membership conditions appropriate to the country
> Individual member
- An individual member is an administrator of a corporate member, an athlete, a coach, a referee or an official or any other person who satisfies the membership conditions;
> Honorary member
- An honorary member is an corporate or individual person who was invited by the Board of directors/Executive Committee and/or a General Meeting/Congress to membership for honorary reasons;


### 2.2 Membership conditions

### 2.2.1. Clubs or similar member

Any club or group wishing to become or remain a member of the Federation as a corporate member must, each year, pay the required dues and fill the membership documentation.

The conditions for corporate membership are the following:

- Be a corporation created under the Corporation law (name the precise law applicable to the constitution of corporations in the country) or comply with whatever regulations and requirements the country or other administration applicable requires for the establishment of a sports club, organisation or national federation.
- Have its head office/venue on the territory of (name the country)


### 2.2.2. Individual member

Any person wishing to become or remain a member of the Federation as an individual member must, each year, pay the required dues and fill the membership documentation.

To become or remain an individual member, the person must be one of the following:

- An administrator of a corporate member
- An athlete
- A coach
- A referee or other official
- A member of the Board/Executive Committee, a committee, commission etc of the Federation or one of its sub-divisions
- Any other entity/person supporting fencing in a category that the Federation desires as members and satisfies the membership conditions


### 2.2.3. Honourary member

To become an honourary member, a person or moral person must meet the following criteria:

- Has made a highly significant contribution to the Federation;
- Has been accepted by the Board of directors;


### 2.3 Membership dues

The amount of the dues for each category of membership is set by decision of the Board of directors. The Board of directors/Executive Committee can impose a special additional membership fee for a specific period of time. No paid or owed membership fee is reimbursed in case of resignation, suspension or expulsion of a member.

### 2.4 Suspension, expulsion, withdrawal and sanctions

The Board of directors/Executive Committee can suspend, expel, or sanction in any other way deemed appropriate, any member who fails to respect the Statutes, Rules and Policies of the Federation or who adopts a conduct prejudicial to the Federation, as provided in chapter XXX (put the chapter number)

The Board's/Executive Committee's decision is final and does not discharge the member of its previous obligations towards the Federation.

A member can resign from membership at any time by sending a written notice to this effect to the Federation's head office. This resignation takes effect on the date mentioned in the notice or, failing such a mention, on the date it was received at the head office.

## III THE CONGRESS

3.1.-Definition: paramount governing body of the National Fencing Federation (NF).

2.1.- Ordinary Congress. Annual
2.2.- Extraordinary Congress. - Extraordinary Congress. Whenever summoned by the President or requested by over two thirds of the Executive Committee/Board members or by typically $10 \%$ of the members (\% dependant on total number of members).
2.3.- Elective Congress. To elect the President and, where appropriate, the Executive Committee of the NF. Normally every 4 years, coinciding with the Olympic year.

## 3.3.- Role - Functions

Adoption of agreements on:

- Annual accounts
- Budgets
- Acquisitions or assignments of real estate
- Loans
- Competition calendar
- Modification of Statutes
- Dissolution
- Election of President and, where appropriate, Executive Committee/Board.


## 3.4.- Composition and representation

- Members (athletes, clubs, referees, technicians, Territorial Federations).
- Right to vote
- Representation (powers)
- Limitations of the right to vote, if applicable (current license)


### 3.5. Agenda

- Who can present proposals (members)
- Deadline for submission of proposals
- Interventions during the congress


## 3.6.- Decisions

- Quorum (50\% members present or represented)
- Adoption of agreements
- Simple majority assumptions
- Assumptions that require a qualified majority (modification of statutes, dissolution)
- Secret ballot (mandatory in elections or at the request of the president or $10 \%$ of the members or when concerning an individual)

## CHAPTER VII - DISCIPLINE

Preamble: Does/will your federation have its own body applying its disciplinary procedures (a commission, the Executive Committee/Board, etc) or will it make use of a juridical body available from its NOC, sports arbitration board, governmental body or similar? ### 7.1 Disciplinary Code.

1) Jurisdiction. Set a criterion to select the body which has the jurisdiction.
2) assure there is a body (usually the executive committee) that execute or control the respect of the decisions;
3) List the person subject to disciplinary rules;
4) Set the penalties that can be granted (i.e. suspension, expulsion, fines etc.);
5) Identify the offences;
6) Specify different cases such as, i.e. multiple offences, complicity;
7) Set the rules for the proof of the guilt or innocence.

### 7.2 Disciplinary Procedure;

## The Complaint

1) set up the complaint rules, i.e., identify persons that can make a complaint, identify the persons who can be the object of a complaint (the defendants) and spell out the categories of offences that are subject to the disciplinary process (and those that are not).
2) Fix the mandatory content of a complaint (i.e. name, date summary, signature etc.) and a deadline to address such a complaint to the body that holds the jurisdiction;
3) Set the composition criteria of the Tribunal and the powers and obligations (Please note that a conflict of interest rule must be applied in fulfilling the composition criteria).

## Procedure before the Tribunal

1) identification of the parties;
2) fix deadline for providing documents and proof (i.e. list of testimonies etc) for both parties
3) set the notification rules (i.e. certified mail etc.) and deadlines.

## Hearings

1) Place of the hearings;
2) Attendance (shouldn't be mandatory for the parties);
3) Witnesses' proceedings rules (In person, in writing, by phone);
4) Decision and notification of decision rule.

## Appeal;

1) Establish the body in charge for the appeal;
2) Deadline of the appeal and form of the application;
3) Proceedings (if external body in accordance with the body rule if internal needs to be established a proceeding or the appeal);
4) Decision and notification rule.

## Emergency;

Establish a body in charge for the urgent decisions (i.e. suspension until the end of proceedings) and rules.
