It can take several weeks to complete the visa application process and receive your documentation, so federations are requested to begin this process as far in advance as possible:

- Event Role
- Passport Issuing Country
- Passport Number
- Passport Expiration Date

Participation & Entries

Categories: Senior Men's and Women's Foil, Individual (Maximum of 12 individuals per country, the organising country may enter up to 20 fencers, plus the number needed to make up the pools.)

Participation: Participation in the competition is open for athletes having a valid FIE license for the current season in accordance with the quotas of the FIE.

Entries:

Entries must be made via the FIE website.

Entry Fees: Entry fees should be paid to USA Fencing by credit card or bank transfer prior to the competition in the amount of 100€ or \$110 USD (based on the exchange rate at the time of registration).. Based upon the final entry list for each national federation, USA Fencing will send an invoice by email. If necessary, cash payments will be able to be made onsite. Bank transfer details are below:

Participation & Entries - Cont'd

Formula: The competition will be fenced according to the official FIE formula.

Equipment: All equipment must be within the FIE standards.

Doping Control: Doping control will be done according to the rules of the FIE.

Ticketing & Venue Access

A list of all athletes, coaches and support personnel should be sent to the organizers by the posted deadline in order to provide accreditations for venue access. All coaches MUST have a valid FIE License for the current season to receive an accreditation.

Spectators and non-accredited individuals will need to purchase tickets in order to access the competition halls.

Tickets may be purchased online before the event by **<u>CLICKING</u>** <u>**HERE**</u>. Prices are \$10 USD for a single day pass or \$25 USD for an event pass which will grant you entry to the venue on all days of competition. Payment may be made by credit card or bank account.

Tickets will also be available for purchase onsite at the competition venue.
