5. Participants:

- Open only to member countries of the Pan American Fencing Confederation.
- Only federations that do not have any athletes qualified through team qualification or through individual AOR per zone, in the weapon in question, can participate in the respective zone qualification events, with a maximum of one (1) athlete per federation by weapon. All fencers must have a valid FIE license and registrations must be made through the FIE website (www.fie.org).



6. Registrations:

Registration fee will be 50 USD per athlete, to be paid in cash on the day of the technical congress.

7. Accreditations:

- Accreditation will be organized at the official hotel for the competition. Working hours are daily from 08:00 to 20:00, from April 4 to April 6, 2024.
- Without accreditation, no participant will be able to carry out the equipment control or enter the competition room.
- The head of the delegation will come to the accreditation office and collect the accreditation cards.
- **A personal photo of the delegate must be submitted by March 15, 2024.**
- Officials and athletes must provide a passport size photo for the creation of their accreditation card (at 300 dpi, digital image size 4.5x5 cm in JPG format) of each participant and send to reservation@esgrimacostarica.net
- The file format: photo name: <country> _ <official / athlete> _ <name>. for example: CRC_Athlete_LASTNAME_firstname.jpg or PUR_Official_PEREZ_Jose.jpg

8. FIE Regulations:

The Competition will be carried out in accordance with the current Statutes and Rules of the FIE. The format of the competition will be the one published by the FIE and available at <https://static.fie.org/uploads/33/165062-regl%20epr.%20cont%20JO%20Paris%202024%20ang.pdf> to the rules published

9. Equipment Requirements:

All equipment must comply with FIE regulations and will be checked under control of the SEMI commission. All equipment must be sent for inspection and marked by the organizer before it can be used in the competition.

Equipment control will be organized at the hotel.

10. Competition Management:

Referees must present themselves during the Referees' meeting on April 05 [at 17:00 at the sport venue](#).

Referees must be properly attired in jacket/blazer and long pants.

- 4- The accreditations will be delivered to the participants once the registration payment has been made at the official hotel.

TRANSPORTATION: Airport-hotel-airport transfers will be coordinated by the Organizing Committee in accordance with the flight information that has previously been sent to the email reservation@esgrimacostarica.net **before April 1**

The cost of these transfers is \$60.00 per person for both routes. It should be noted that it will be transportation hired especially for the event, complying with all the protocols established by the Ministry of Health of Costa Rica.
