Decision of the FIE Doping Disciplinary Tribunal of 10 May 2024

Art. 2.4 FIE ADR (three missed tests within a twelve-month period)

Sanctions:

-Period of Ineligibility of two years from 10 May 2024 until 9 May 2026;

-Disqualification of all of Ms Kun's results earned from the date of the third missed test (i.e. 24 August 2023) through the commencement

of the period of Ineligibility (i.e. 10 May 2024) including forfeiture of any medals, points and prizes;

-A fine of CHF 5'000.- is imposed on Ms Kun.
