Participation

Alt 1. Each national federation may enter a maximum of 12 fencers.

The organizing country may enter up to 20 fencers plus the number needed to make up the pools. Alt 2. For Individual World Cup competitions outside Europe, the organizing country may enter up to 30 fencers plus the number needed to make up the pools. Team participation is open to all countries and limited to one team per weapon per country.







Entry

Every competitor is required to be licensed for the 2024 - 2025 season. No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition, Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31st December of the year preceding the year in which the competition takes place (cf o.80) Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).

Entry Fee

25 EURO for individuals

150 EURO for the teams

Rules and equipment control:

Competition and equipment control in accordance with all FIE rules.

Anti-Doping controls:

Doping control will be done according to FIE rules.

Referee Obligation

Participating countries must be accompanied by referee with FIE A, B licenses as below (cf. t.35). Delegations not respecting the quota must pay a fine of EUR 1000 per referee.

1-4 fencers	No referee required	
5-9 fencers	1 referee	
10 or more	2 referees	







Formula

Individual competitions – One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination.

Team competitions – Integral direct elimination with a direct elimination table which may be incomplete. All places in the table up to 16th place will be fought for. From 17th place onwards teams will be classified, within each round of the table, according to their initial place in the table. The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf. o.86); the remaining ranked teams will be placed in the table by drawing of lots in pairs. The teams that are not classified will occupy the last places in the table and will be separated by drawing of lots (cf.o.42-o.47).

VISA

- A copy of their passports and a passport (6 months 'validity) sized photo in addition to a modern portrait.
- Visa fee will be only <u>60 EUR per person</u>. It is extremely important that all requests are received by the stated date to ensure that the required visas are obtained on time.
- Any requests received after this date will not be accepted.
