**Categories:** Junior Men's Sabre and Junior Women's Sabre, Individual and Team

**Participation:** Participation in the competition is open for the athletes having valid FIE license for 2024-2025 season in accordance with the quotas of the FIE.

**Entries:** Entries must be made via the FIE website at least (7) days prior to competition. Please [click here](#) to log in to your admin portal to register.

**Entry Fees:** Must be made on-site no less than one hour prior to the beginning of each event. Individual event fees are €25 or \$30 USD and the team event fee €150 or \$165 USD. For team events, all countries participating must bring one referee per team.

**Individual Competition Formula:** One qualifying round of pools, a direct elimination table to qualify for a final by direct elimination.

**Team Competition Formula:** Direct elimination

**Equipment:** All equipment must be within FIE standards.

**Doping Control:** Doping control will be done according to the rules of the FIE.

**Referees:** In accordance with the FIE Rules for the number of FIE A or B Grade referees, countries must provide the required number of referees:

- 1-4 Fencers: No Referee
- 5-9 Fencers: 1 Referee
- 10-12 Fencers: 2 Referees

**Competition Schedule:** The schedule is provisional. The organizers have a right to change the program.
