Participation:

Participation is not limited.

#### Entry:

Open to all fencers with valid **2025-2026 FIE License**. No fencer may obtain an FIE licence, enabling him or her to enter for an official FIE competition, until he or she has reached their 13<sup>th</sup> birthday.

Entries of fencers and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules.

Entry fee:

Individual competition: **50€** 

The entry fee is paid at registration desk before the start of the competition.

## **Referee Obligation:**

Each country is required to send FIE A or B Grade referees in accordance with FIE rule o.25:

1–4 fencers - No obligation to provide a referee

5–9 fencers - One referee 10 or more fencers - Two referees.

- \* The referees (who must have an FIE category in the weapon of the competition) must be entered via the FIE website 7 days before the competition (midnight, Lausanne time).
- \* Should a national federation not provide the required number of referees, a fine according to FIE Organisation Rules (cf o.31, table of financial penalties and fines) will be inflicted on it.
- \* Non respect of quota is sanctioned by 1000 € for every missing referee per competition and shall be paid by the fencers National Federation to the Organiser at the same time as the information is sent to the Organizer (according to FIE Rule 0.31.)

#### Formula:

According to FIE regulations, formula for junior competitions. One round of pools, from which 20-30% of fencers will be eliminated, followed by Direct Elimination without repechage.

#### **Prizes:**

Cups for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places assured by Organisers both for male and female winners, sponsor gifts.

### Doping:

Doping test will be conducted according to the FIE rules.

## **Accommodation and Transport:**

## **Visa Support:**

Since Croatia is a part of EU Schengen zone, we suggest all fencers requiring Visa to ask for a tourist visa, considering that our Ministry of foreign affairs started to charge a process for sport visa.

In case you can't apply for a tourist visa, we will help you with the process for sport visa and will charge you only for the cost that is required by our Ministry of foreign affairs.
