PARTICIPATION

Individual Event

- Each federation may enter up to 12 fencers.
- The organising country may enter up to 20 fencers plus the number needed to make up the pools (local fencers only).

ENTRIES

Entries for fencers and coaches must be made strictly via the FIE website (www.fie.org), in accordance with FIE Rules and regulatory deadlines.

Notes:

Coaches must be entered via the FIE website and must have a FIE license valid for the current season.

Eligibility:

- All participants must hold a FIE license valid for the current season.
- Minimum age: No fencer may obtain an FIE license, enabling him or her to enter for an official FIE competition, until he or she has reached their 13th birthday.

ENTRY FEES

Entry Fee 80 EURO - individuals, 400 EURO - teams

Fees may be paid: in cash at registration before the start of the competition in EUR. If you wish to pay in advance by

bank transfer, please send us an email with the names of the participants.

Deadline: Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54). (Before 18. March 2026)

REFEREE OBLIGATION

Referees are appointed by the FIE.

Delegations do not have to provide referees.

Rules and equipment control: Competition and equipment control in accordance with all FIE rules.

COMPETITION FORMULA

Individual competitions – One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination.

Team competitions – Integral direct elimination with a direct elimination table which may be incomplete. All places in the table up to 16th place will be fought for. From 17

th place onwards teams will be classified, within each round of the table, according to their initial place in the table. The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf.o.86); the remaining ranked teams will be placed in the table by drawing of lots in pairs. The teams that are not classified will occupy the last places in the table, and will be separated by drawing of lots (cf. o.42-o.47).

MANDATORY

Competition results/management software

Fencing Time is the FIE official and mandatory competition results / management software . It is obligatory for senior events.

ANTI-DOPING

Anti-Doping control must be done according to FIE rules which can be found on:
