PARTICIPATION

Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.

ENTRIES

Open to all fencers with valid 2025-2026 FIE License.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54)..



ENTRY FEES

Fees may be paid: € 120

An entry fee of **€ 120** per fencer will be given to the organiser until 17:00 on 30th April at the desk in the venue.

REFEREE OBLIGATION

The referees are designated by the FIE and delegations will not have to provide any referees.

COMPETITION FORMULA

One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination. For your information, please check FIE website and KFF website. (<http://fencing.sports.or.kr>)

MANDATORY

Competition results/management software

Fencing Time is the FIE official and mandatory competition results/management software. It is obligatory for senior events.

1-2. Countries not applicable to issuing K-ETA, must need Visa from the Embassy

Accordingly, you must first contact the Korean Embassy in your country to confirm whether a visa application is required, as well as to verify the application procedures and the expected processing time. After confirming this information, please submit your request for an official visa invitation letter to our Federation.

(The deadline for requesting the visa invitation letter is April 1, 2026.)
