In view of the inclusion of Zonal Championships in the FIE rankings, the following rules concerning the participation were adopted :

- for the individual competitions of **Junior and Senior** Zonal Championships, 4 fencers maximum per country, per weapon ;
- 1 team (composed of three fencers with or without a reserve) per country and per weapon ;

- entries of fencers and teams to be made via the FIE Internet website, 15 days before the date of the 1<sup>st</sup> event of the Zonal Championships at the latest.

## II. National Federation of Serbia


