Please find below the decisions taken by the Executive Committee at its meeting of 23 and 24 April 2005 in Lausanne (SUI) :

a) Non-combativity : Urgent decision of 7 March 2005, urgent letter nr 5/05.

Following the requests of details from national federations and the difficulties of application met by the referees, the Executive Committee has modified the text of the article t.87 regarding non-combativity. This new text is attached.

b) Conductive T-Shirt

We remind you that the conductive T-Shirt, which must be purchased by the fencers participating in Grand Prix competitions and World Championships at Sabre, is part of the fencers' equipment. The Allstar and STM companies are providing this T-Shirt.

c) Logos of national federations

The Executive Committee has decided that logos of national federations on athletes' clothing **must be worn on both legs**; they are optional on the arms.

We remind you that logos of national federations must be submitted to the Executive Committee for approval, and are then published on the FIE Web site. The national federations, which have not yet submitted their logo and have athletes participating in FIE official competitions, must urgently send their logo in colour to the following e-mail address : info@fie.ch

The non-respect of the above dispositions will prevent your fencers from participating in competition because of material non-conform.
