III - Confirmation and Accreditation

- 1) The federations which are not up to date with their annual membership fees must settle them with Mr Peter Jacobs or Ms Nathalie Rodriguez before 5 April 2008.
- 2) The presence of a participant for individual or team competitions must be confirmed when accreditation is collected; this procedure replaces any other method of confirming an athlete's participation to the Directoire Technique.
- 3) The accreditation desk and accreditation system will remain operational until the end of the Championships.
- 4) The accreditations will be distributed to the heads of delegation upon presentation of proof of identity (passports...) of each member of their delegation and after payment of the entry fees.
- 5) **Accreditations must be carried out, at the latest, at 10 a.m. the day before the competition concerned.**

IV – Individual Competitions

- 1) **At midday** the day before the competition, we will put up:
 - a) the list of participants per country
 - b) the list of participants by their initial ranking in the competition concerned
- 2) **3 p.m.**, at the latest, is the deadline for any objection or withdrawal that has to be presented to the Directoire Technique. No changes will be accepted after this deadline.
- 3) **At 4 p.m.**, the following will be displayed:
 - a) final version of the pools
 - b) timetable and assignment of pistes for the entire following day
 - c) competition formula
 - at the information points
 - in the delegations' pigeon-hole boxes
 - in the official hotels
- 4) **Initial cadet classification criteria for cadet competitions**

When drawing pools in the World Cadet Championships, the order of strength is established according to the following criteria:

 1. The top 8 in the previous year's World Cadet Championship (class. number =actual rank)
 2. The 64 highest ranked in the official FIE junior ranking (class. number =100+ actual rank)
 3. Those placed 9-32 in the previous year's World Cadet Championship (class. number= 200+ actual rank)
 4. Those placed 65 onwards in the official FIE junior ranking (class. number= 300+ actual rank)
 5. Criteria according to the DT's decision:

- a) Fencers from countries that have 3 or more fencers in the official FIE junior ranking (with points) of the weapon in question (class. number: 899)
- b) Fencers from countries that have 1 or 2 fencers in the official FIE junior ranking (with points) of the weapon in question (class. number: 999)
- c) Fencers from countries that have no fencers in the official FIE junior ranking (with points) of the weapon in question (class. number: 1099)

V – Team Competitions

- 1) For any changes concerning the teams, requests must be made to the Directoire Technique by 10 a.m. the day before the competition.
- 2) Drawing of lots to place teams at the top and bottom of the bout sheet, as provided for by the Rules, will take place at the indicated spots.

VI – Event Venue (see attached map)

Initial Material Control Room: above the gallery with reserved access

Call Room: map of ground floor, above the central gallery

Material Control Room: next to the call room

Medical Stations: 1) ground floor, 2) room with coloured pistes 1, 2, 3, 4

Only the fencers concerned, referees and staff for the pistes are authorised to access the zones of combat defined by barriers.

The fencers who are in the zones of combat must keep their belongings in closed fencing bags at the end of the piste.

All fencers and referees must be present on the pistes 10 minutes before the beginning of the pools.

VIII – Information Points

There will be three information points:

- Near the mixed zone
- Near the referees' room
- On a notice board by the qualification pistes

IX - Confirmation of Results

- 1) Fencers are responsible for checking the results of the pools and direct elimination sheets to verify that the results have been correctly registered. The screens installed by every piste and those in various areas in the halls will make it possible to quickly check up-dated results of the rounds of pools and direct elimination bouts.
- 2) To avoid any kind of error, the DT will publish the results of the pools and the list of qualified and eliminated fencers immediately after the end of the round of pools. The delegations must raise any objections they may have **within a time limit of 5 minutes**.
- 3) The direct elimination tables, with timetables and pistes, will be displayed after **this 5 minutes time limit** and after each round of table.
- 4) **No call will be made by microphone.**

X - Organisation of the Direct Elimination Table to the Final

For conventional weapons, the table of 32 of the individual events will take place entirely on the 4-5 pistes, which are equipped for video-refereeing.

- 1) The fencers must present themselves in the call room 20 minutes before the time set for the beginning of their bouts in order to be led to the coloured pistes.

The fencers who have won bouts of the table of 64 must immediately go to the weapons control room (foil and sabre for wireless equipment) located next to the call room, leave their material there so that it can be checked, and then come back to the call room as specified above.

- 2) Special areas, defined by barriers and near the gallery, are assigned to coaches around the coloured pistes. They are only allowed to leave these areas during the 1 minute break.
- 3) A special protocol is applied from the table of 32. The fencers, in full fencing attire, are escorted with the referees from the call room to their respective pistes. After the first round of the table of 32, the bouts take place one after the other as soon as pistes become available, as long as the bouts do not start more than 5 minutes before the official schedule.

4) The SEMI delegate will give the weapons in a **closed** fencing bag to the volunteers, who will escort the athletes to the coloured pistes. The fencing bag will remain closed during the entire combat. The athletes will leave the call room ready to fence, i.e. with their mask and weapon plugged into the body wire.

XI – Video Refereeing

Video-refereeing is compulsory at Grand Prix competitions and World Championships.

- In individual events, the fencer has:

- in the pools using the video-refereeing system, one possible appeal during each bout;
- in direct elimination bouts, two possible appeals to video-refereeing.

Should the referee prove the fencer who appealed to the video-refereeing right, the latter is entitled to get back his possibility of appeal.

- In team events, the fencers keep one possible appeal to the video-refereeing per relay and they are entitled to get back this appeal should the referee prove them right.

In the case of an appeal to the video-refereeing, the referee will move towards the refereeing delegate, they will watch the video together and after consultation with the delegate, the referee will give his final decision.

At conventional weapons, when both lamps are on, the referee must look at his monitor before making a decision.

If both fencers are equal at the end of the match, the referee must use the video-refereeing system **and go next to the refereeing delegate. They will examine the video together, and after consulting the delegate, the referee will give his final decision without the possibility of consulting the video again.**

The last action will be replayed on the referee's and the refereeing delegate's monitors, first at the real speed and then in slow motion, at **20%**.

The refereeing delegate has the possibility to request that the referee review his decision at any time.

The person(s) checking the referee's decision does not have to be a member of the refereeing commission. For the World Championships, the refereeing head delegate will designate this or these person(s).

Le tableau récapitulatif des lames homologuées indique pour chaque fabricant les dates d'homologation et des contrôles périodiques. Les lames homologuées sont marquées avec des dates incluses dans la période d'une année qui suit la date d'homologation. Dès 1990, les lames doivent être entièrement conformes aux « Spécifications pour la fabrication des lames pour l'escrime » contenues dans les annexes « A » du Règlement du matériel, disponible sur le site www.fie.ch.

Le Congrès de la FIE de juillet 1994 a décidé que les lames doivent être homologuées par la Commission SEMI pour que les fabricants soient autorisés à appliquer le label FIE sur leurs lames. Et que les différentes productions de lames seront soumises à des contrôles périodiques.

Selon la décision du Congrès FIE de décembre 2001, les lames portant le label FIE pourront être utilisées sans limite de validité. Après avoir obtenu une homologation, les fabricants peuvent demander une re-homologation, mais à la condition qu'ils aient soumis leur production aux contrôles périodiques au moins deux fois dans la période de cinq ans qui suivent la date d'homologation initiale.

- In addition to the above mentioned logos all Transparent Visors Masks must have the CE/EC logo, mention the EN 13567 and must have passed the EC and SEMI tests.
- The Visor must have the month and year of fabrication stamped in a permanent and visible way; and the visor is valid for 2 years counting from that date.
- Marking Example in the mask:

The manufacturer of a mask that received a CE and FIE homologation on 2004, can mark it with: FIE and CE logo, their logo, 1600 newton and the year of manufacturing 2004, 2005, 2006, 2007 ...
