SUMMARY OF THE MODIFICATIONS OF ORGANIZATION RULES BOOK

The main changes that have been introduced are:

- General revision of the languages (French and English), to adopt more proper and uniform wording.
- Control of accurate consistency between French and English versions.
- Transfer of some articles within the book for a more logical sequence and to concentrate rules regarding certain items in a single chapter.
- Transfer of some items from Administration Rules or Technical book for consistency and from Organization book to Book of regulations (Cahier des charges); this part of the work shall be released later.
- Introduction of rules existing de facto but so far applied through letters or other FIE documents.
- Introduction of the rules regarding the Veterans Team World championships already in use, but not formally in the book. It must be noted that a proposal of modification of this section has been presented by the Veterans Council.

The resulting text indicates cancellations and additions in barred red and blue colours. The numbers of cross referred articles has been put in evidence with a yellow background, because they will be refined only after approval from Comex and Congress. The same concept is for the index and the list of subjects at the end, as well as the annexes.

Here below the list of modifications; simple corrections of wording or of the layout of the text are not mentioned:
