ENTRIES

The Female Fencers (junior, born on 1996 and later) provided FIE license 2015/2016. Every country has the right to 12 fencers and a team. The entries must be received no later than 7 days before the event, exclusively on the website of the FIE (cf.o.54). The organizer can not accept other entries.

REFEREES

Each country has to offer to the Technical Board a number of referees by the rules of the FIE: 1 to 4 fencers: 0 referees; 5 to 9 fencers: 1 referee; 10 or more fencers: two referees; Team: 1 referee. If the required number of referees is not respected, regulations of the FIE (cf.o.86) will be applied.
