1. WELCOME

The President of Coaching Council welcomes everybody at the FIE Coaches Council meeting. The agenda for the meeting was circulated. G. Tyshler gave short report on the year of work of the coaching council and informed the council that he have invited to the meeting members of the FIE refereeing committee available. Unfortunately, no refereeing committee members are present. Materials from Coaching Council are now available at the FIE web site.

1.2 MINUTES

The minutes of the previous council meeting were circulated and approved via email.

2. PROPOSALS FOR THE 2015 CONGRESS

PROPOSALS FOR THE 2015 CONGRESS WITH COACHING COUNCIL COMMENTS DOCUMENT ATTACHED.

SPECIAL COMMMENTS

- Coaching council in general positively looking at "Reintroducing the fleche for the sabre", but this proposal must be tested to prepare correct wording in the rules to avoid "running on the piste" instead of executing the classical "fleche attack".
- "At foil it is forbidden, during the course of fencing, to advance the shoulder of the non-sword arm in front of the shoulder of the sword-arm (cf.t.19). Any hits scored by the fencer at fault while committing this offence will annulled." In this case, Coaching Council will ask referees to look closely at fencing phrases in close quarters, especially at the situations when fencers using "corps a corps" to avoid being hit with correct repost.

3. Discussions:

- The longest discussion was about the changing the blocking time in sabre. Practically all participants of the meeting took part in discussion. Two opinions were represented. One is to leave 120 mil blocking time in place. That will have the sabre refereeing simpler and less mistakes from the refereeing. Second is to change to 170 mil blocking time to have more valid ripostes and have sabre closer to original classical conventional weapon. Finally the vote was taken in favour for changing to 170 mil
- 4. Points for discussion with refereeing committee.
- Interpretation and application of: "attack ", "preparation", "attack on a preparation" in sabre and foil. Video examples on the FIE web site.
- Separate independent 3 video referees for the semi-finals and finals or possibly for all DE bouts. Joint discussion with SEMI committee.
- The FIE referees list for the season. The referees in the list cannot attend any FIE competitions in capacity of Head of Delegation, coach or any other official position.
- 5. Joint meetings with Rules committee and Refereeing committee were conducted, few maters were discussed, no decisions were taken.

CONCLUSION

Dr. G. Tyshler thanked everybody for the work done. Draught of the minutes will be circulated by the president to all members for comments. The date for the next meeting will be announced. Meeting closed.
