Control Anti- Doping	Anti Doping: Doping controls will be conducted in accordance with Anti- Doping Rules of the FIE and WADA protocols.

Video Arbitration	Video system is used arbitration approved by the FIE.
Material check.	It will be held at the site of the competition, the day before each test, according to schedules that are reported in Annexx I attached.
Opening Ceremony and Protocol	For purposes of protocol of the opening ceremony, each country should appoint a representative to the ceremony, which will carry the full national uniform, a CD or pendrive with national anthem and the flag of your country.  The opening ceremony will be held on June 22, 2016, at 18:00.
Technical Directory	The Chairman of the Technical Board, Commission's Delegates (Refereeing, Medical and Semi) and referees of competition will be proposed by the CPE to the Executive Committee of the FIE, which will give its ratification. The Organizing Committee will cover the costs according to the Administrative Regulation of the FIE.
Referees	As it noted, the FIE, by proposal from the CPE, will appoint the CEO of referees and 6 referees, corresponding to the organizing federation assume their expenses under Administrative Regulations of the FIE. Each participating country with more than 4 fencers should consider with his delegation, one referee FIE at his own charge; the organizer will cover the costs of internal transport and food, of those who are appointed formally.
